Notice is hereby given that Teindland Wind Farm Limited, ("the Company") with company registration number SC689060, having its registered address Floor 1/1 39 St. Vincent Place, Glasgow, Scotland, G1 2ER, has applied to the Scottish Ministers for consent under section 36 of the Electricity Act 1989 to construct and operate Teindland Wind Farm on land approximately 4.4 kilometres (km) north of the village of Rothes, Moray (Central Grid Reference 328463 853580). The installed capacity of the proposed Teindland Wind Farm would be up to 171.4 MW, comprising 12 wind turbines with a ground to blade tip height of up to 230 metres and a Battery Energy Storage System (BESS) with approximately 85 MW (peak output) and a storage capacity of 170 MW-hours. The proposal is subject to Environmental Impact Assessment (EIA) and an EIA Report has been produced.

The Company has also requested a direction under section 57(2) of the Town and Country Planning (Scotland) Act 1997 that planning permission for the development be deemed to be granted.

- Consent the proposal, with or without conditions attached; or
- Reject the proposal
